We had an outing to the Bakken Museum that included some outdoor fun and a fantastic sunset dinner at The Tin Fish on Lake Calhoun, finishing the evening with a bonfire at the home of social director Les Kraus. The Halloween party planned by Rachel Dana was a hit. Those attending dressed up in some creative costumes and we had the first use of our new fire pit, courtesy of Tim McGlynn – Thanks Tim! We had a couple of good potlucks for Thanksgiving and the winter holidays, as well as our first winter Solstice

party. Vicki Larson organized that event which included a yule log hunt, s'mores over the bonfire, drumming, poetry and other readings, singing, and wassail ("drink hail"). We had a great time and everyone seemed to enjoy the alternative winter celebration. I hope to see this as a new LFUU tradition. There are plans to move forward starting in January with a monthly movie night at Fellowship. These will be casual, fun evenings with movies for both kids and adults; the main focus will be on just getting together to socialize and getting to know each other, especially anyone new to the Fellowship.

There have been some good programs this past fall and early winter - most of which were led by in-house contacts. We have such a great pool of talented individuals within our Fellowship who have vast experience – or opinions ;) – in a wide variety of topics. Marnie Karger and I still need another person or two to join the committee to lend a hand and get a feel for what we do to coordinate programs. I am in my third year and Marnie in her second year and we'll be looking to transition out in the coming year or two. If interested, please talk to either of us. Mark Plewka and Robin Dodson organized another successful effort for Kids Against Hunger, as well as a morning of volunteer raking. We raked at two houses in need of help this year and had a good time giving back to the community. The LGBTQ group "We Get You" continues to meet monthly at the A-Frame. The group has dropped in size, but those who still come appreciate the use of our facility as a safe haven to meet and just hang out for a few hours together. Laurie Gauer is our contact with the group and will maintain that relationship and LFUU's involvement with this group moving forward.

The Board is looking to update the electrical system in the A-Frame. The building is already under-powered as the circuit breaker flips quite frequently if the wrong combinations of electric items are turned on simultaneously. Don Penn has a projection / audio system he is donating that will require more power to come into the building. In addition, there is talk of removing the large, inefficient gas water heater and replacing it with smaller, green system that would run on electricity. Estimates from contractors are being

compiled and the work should start in the coming month or two. The Board also discussed doing an auction fund-raiser (in the spring) to cover the cost of this electrical upgrade in addition to other expenses. More on that to come soon.

January 8 — Climate Change: What do we really know? Presented by Dr. John Abraham, Associate Professor, University of St. Thomas

We'll focus on how these varied perspectives have changed or remained static through the years.

While we cherish diversity, at least in principle, we often find ourselves exasperated and despairing in the face of caustic attacks on our values and perspectives. Let's consider how we might engage collaboratively and constructively in these charged and fragmented times. Our presenter Jean Greenwood is a Presbyterian minister who has been active in the field of restorative justice since 1991, as mediator, facilitator, circle keeper, researcher, writer, international consultant and trainer in victim offender dialogue, the circle process, and wider applications of a restorative paradigm.
